

On making amendments to the Technical Document "TRACECA Multilateral Permit" User Guide adopted on 29 January 2015 in Istanbul, Republic of Türkiye

With a view to further developing international road transport connections along the Europe-the Caucasus-Asia corridor,

pursuant to the provisions of the Technical Annex on International Road Transport to the Basic Agreement and the document "TRACECA Multilateral Permit" User Guide,

with the aim of regulating the procedure for determining the number of and creating conditions for the transition to the application of electronic forms of TRACECA multilateral permits for each member country,

the Plenipotentiaries of the member countries of the TRACECA Multilateral Permits System

HAVE DECIDED:

- 1. To make the following amendments to the Technical Document "TRACECA Multilateral Permit" User Guide:
 - 1.1. The second paragraph of point 2.2. should be worded as follows:
 - "2.2. The format of the paper and electronic TRACECA permit form must correspond to the standard, specified in Appendix 1 of this Guide (in agreement with the member countries of the TRACECA Permits System, the placement of graphical means presenting digital and/or alphabetic data - barcodes or their other matrix types may additionally be provided on paper and electronic TRACECA permit forms) for automatic reading of serial numbers.";
 - 1.2. The title of Section 6 should be worded as follows:
 - "6. Drafting, Issuance, Record, Use and Return of paper TRACECA permit forms".
 - 1.3. To supplement with the Section 6-1 as follows:
 - "6-1. Application of electronic TRACECA permit forms.
 - 6-1.1. The transition to the application of electronic TRACECA permit forms without the use of paper forms shall be carried out from a date agreed upon by all member countries of the TRACECA Permits System.
 - 6-1.2. The application of electronic TRACECA permit forms shall be carried out using an information system, putting into operation, technical support and maintenance of which is carried out at the expense of the budget of the PS IGC TRACECA.
 - 6-1.3 The competent authorities of the member countries of the TRACECA Permits System shall ensure the exchange of information provided in the TRACECA permit form between the information system and the national information systems.

- 6-1.4 The electronic TRACECA permits shall be distributed by the competent authority (authorities) of the member country of the TRACECA Permits System for vehicles registered in this country, according to the provisions of points 6.3., 6.4., 6.8.-6.10, of this Guide.
- 6-1.5. The electronic TRACECA permit shall be filled in the MLA official languages (English and Russian) on the basis of the information given in the application and vehicle registration documents.
- 6-1.6 The Guide for using the information system shall be prepared by the PS IGC TRACECA and agreed with the competent authorities of the member country of the TRACECA Permits System.".
- 1.4. To approve Appendix 2 to the Technical Document "TRACECA Multilateral Permit" User Guide in the new edition in accordance with Annex 1 to this Decision.
- For the Permanent Secretariat of the Intergovernmental Commission TRACECA to ensure the production of TRACECA multilateral permit forms according to the new procedure of generating serial numbers for each member country of the TRACECA Permits System.
- 3. For member countries of the TRACECA Permits System to take the necessary measures to ensure awareness of the relevant authorized bodies of the decision taken until 01 December 2025.
 - 4. The present Decision enters into force from « » 2025.
