The Chairman of the BC shall be elected at the meeting by a majority of votes for one calendar year without a limit on the number of extensions and shall carry out his/her work to achieve the aims of the BC, as well as shall:	It is proposed to delete and revise the content of the point.	<p>- It is proposed to revise the content of the point due to the absence of specified requirements for candidates (work experience, current status and place of work, eligibility), detailed methods and procedures for nominating candidates for the position of Chairman, the issue of vote counting during the election (anonymous or open format) and to clarify how the votes of online participants who were unable to attend the election in person will be counted (if an anonymous format is used).</p> <p>- It is necessary to revise the term of office, namely, to delete the wording "<i>without a limit on the number of extensions</i>", and to add a new point with a detailed indication of the grounds and procedure for possible early termination of office.</p>	
2	Turkmenistan	11. ... – make decisions on the formation of ad hoc working groups on the most problematic issues requiring long-term study, as well as on holding joint events (exhibitions, conferences, seminars, etc.);	11. ... “on the basis of a decision adopted by all members participating in the BC Meeting, shall be engaged in the formation of ad hoc working groups on the necessary areas, as well as in the holding of joint events (exhibitions, conferences, seminars, etc.).”

GENERAL COMMENTS					
5	Turkmenistan			To consider the exclusion of financing of any BC activities by the PS IGC TRACECA, with the exception of funds allocated from the budget for holding BC meetings via web conferencing (online) but no more than twice a year. In the event that the BC establishes ad hoc working groups on the necessary areas, the financing of their activities shall be carried out without the allocation of any funds from the PS IGC TRACECA budget.
